It is in the best interest of MMH and all retailers to be subject to a policy of advertising and sales which is even-handed and straightforward. Internet advertisement and sales may undermine a product and its name and may adversely affect resellers by unfair competition. Customer loyalty is important to all resellers and MMH seeks to assist retailers in maintaining customer loyalty by imposing a MAP by this directive.

Placement of products with your company is contingent on your company accepting the terms set forth below and returning the MAP Agreement Confirmation form which is provided to you for signature.

You are advised that a breach of the following policy by your company, intentionally or negligently, without regard to the number of violations, may result in termination of your relationship with MMH, with or without advance notice, and MMH products may no longer be shipped to your company. Your company shall abide by the following is its advertisements and sales:

1. From time to time, MMH shall provide your company with a Manufacturer's Suggested Retail Price (MSRP) for each product. 6.
